A. <u>Description of Proposed Action</u>: (1 or 2 sentences; include title, general activities, location, timeframe)

The Preliminary Real Estate Plan (PREP) for KCNSC New Mexico Operations' (NMO) *Craddock D Facility* at 2400 Alamo Blvd. SE at Albuquerque, New Mexico is to acquire the lease on this building to support the ongoing site missions. The lease includes 17,136 square feet of light production, storage, and depot space by for the entire building of Craddock D. No processes or equipment will be moved, modified or relocated. The only modifications being planned will be for the remodeling required for occupancy in Craddock D. These modifications will be to remove a few walls and lab cabinets, installing security locks, alarms, and cameras for property protection, adding IT data cabling for computers, general cleanup and painting, and adding desks, computers, shelving and racking system, and printers for general office work.

B. Number and Title of the Categorical Exclusion Being Applied: (See text in 10 CFR 1021, Subpart D.)

- B 1.3 Routine Maintenance
- **B1.24** Property Transfers
- B1.31 Installation or relocation of machinery and equipment
- B2.1 Workplace enhancements

All activities are covered by the Categorical Exclusions listed above.

NMO facility operations were assessed under DOE EIS 0281: Sitewide Environmental Impact Statement for Sandia National Laboratory, New Mexico.
